MORE than 100,000 eco protesters snaked through Glasgow yesterday in one of Scotland's biggest ever demos. The massive crowd braved heavy rain and strong winds to demand world leaders tackle the climate emergency. The three-mile march from Kelvingrove Park to Glasgow Green came on a Global Day of Action coinciding with the city's COP26 summit. The next COP is the most important COP.....

Glasgow Climate Pact

- Calls for a **phase down coal power and phase out fossil fuel subsidies**; invites reduction of **non CO2 gases including methane by 2030** (first time for UNFCCC)
- Resolves to pursue efforts to **limit temperature rise to 1.5C** recognizing this requires **reducing CO2 by 45% by 2030** from 2010 levels and **net zero around mid century**
- Requests Parties to **revisit and strengthen 2030 targets** by end of 2022 as necessary to **align with the Paris temperature goal**
- Urges Parties to communicate **Long Term Strategies** towards a just transition to net zero emissions by or around mid-century
- Establishes a **work programme** to urgently scale up mitigation ambition and implementation with **updated NDC synthesis report** and an **annual ministerial round table on pre-2030 ambition** beginning at CMA4
- Update of NDC and LTS synthesis reports

Glasgow Climate Pact

Loss and damage

- Establishes the **Glasgow Dialogue** to discuss the **arrangements for funding of activities to avert, minimise and address Loss and Damage** (starting in June 2022 and ending in June 2024)
- Strengthens the **Santiago Network** of agencies that provide financial and technical assistance to countries experiencing extreme and slow-onset impacts of climate change
- Urges developed countries and other stakeholders to provide **enhanced and additional support** for activities addressing loss and damage

Adaptation

- Establishes the **Glasgow –Sharm el-Sheik work programme on the global goal on Adaptation** (starting in June 2022 and ending in June 2024)
- Urges **developed countries to double adaptation finance** from 2019 levels by 2025 (approx from USD 20bn to 40bn)

Climate finance

- Initiates the deliberations on the **New Quantified Collective Goal (post 2025)** and adoption of an inclusive and transparent process/work programme

Others

- **Delivery of Art 6 work programmes**

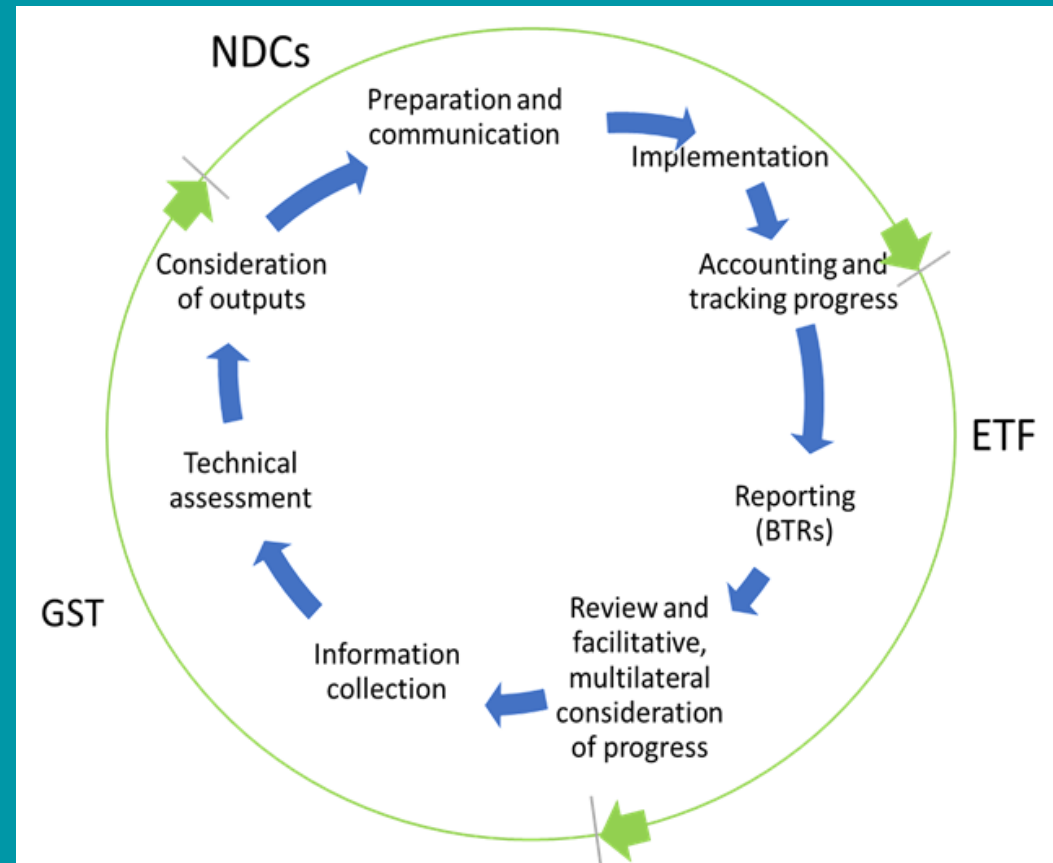

- Parties and stakeholders confirmed the importance and priority of **Adaptation and Resilience** for all countries and communities, particularly developing countries
- The Glasgow outcomes also highlighted the centrality of urgently **scaling up support**, including **finance, capacity building, and technology transfer**, to enhance adaptive capacity, strengthen resilience and reduce vulnerability to climate change

Selected DI focus areas

- Showcasing concrete Danish climate solutions to implement and reach global climate targets
- Ambition and leading by example
- Public-private cooperation
- Just transition – a fair and balanced greening
- Thematic (among others)
 - Phasing out fossil fuels (green energy, EE, hard to abate etc.)

COP FOR BEGINNERS

COP: Conference Of the Parties

UNFCCC: United Nations framework Convention on Climate Change Responsible for the COP and all intergovernmental climate change negotiations

IMPLEMENTATION of UNFCCC (convention 1992), Kyoto Protocol (1997), Paris Agreement (2015). Paris Agreement: First global (196 parties), legally binding climate agreement. Keep temperature rise below 2 C (1.5 C ideal).

Since 2015? – how do we implement the Paris Agreement and ensure ambitious national commitments (NDCs: Nationally Determined Contributions)? EU NDC: 55% reduction by 2030 (1990 level)

WHY COP?

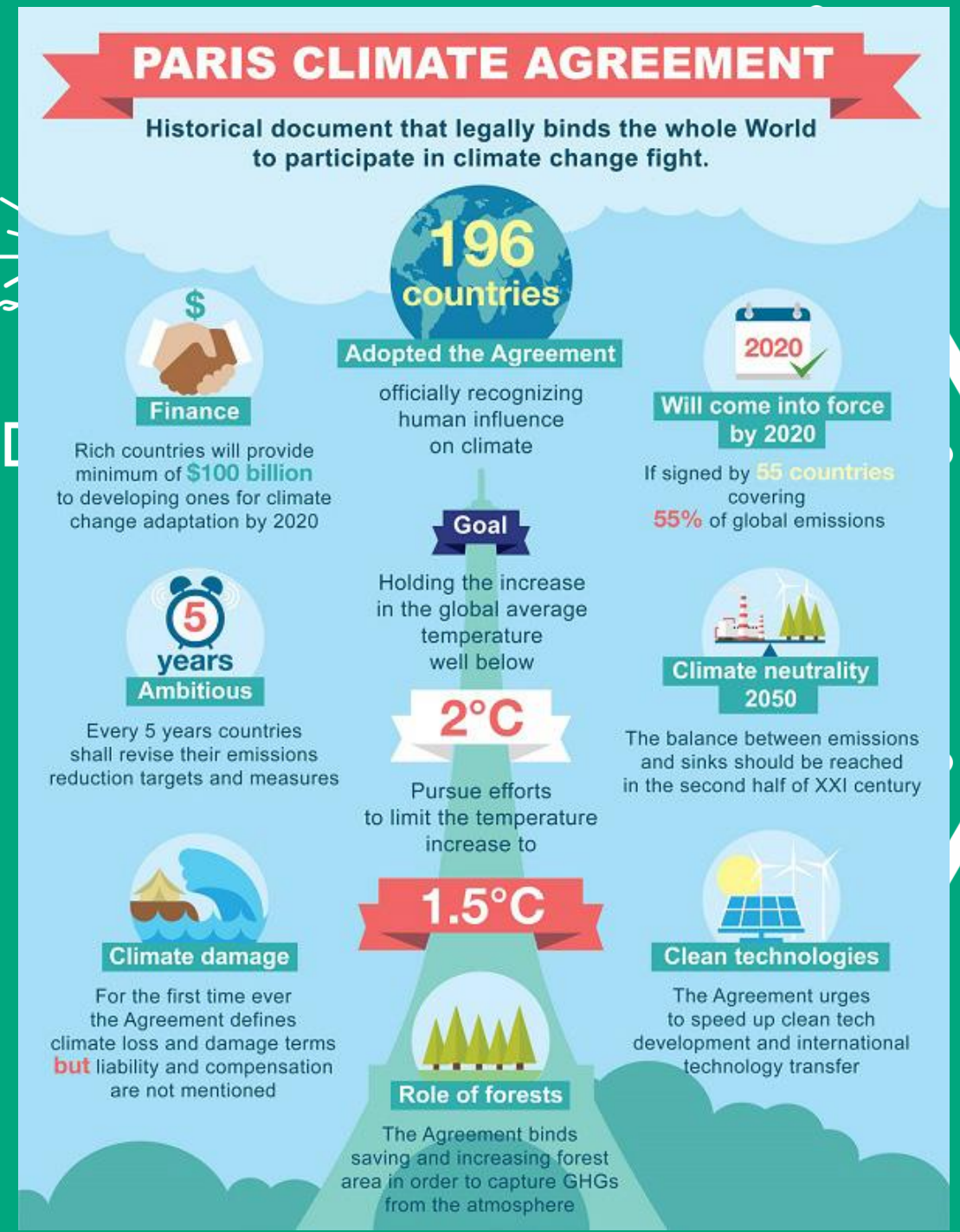
Climate change, climate crisis, climate challenge – global issue, requiring global action and goals.

One country – one vote. All countries have influence ensuring equality and developing countries' influence.

INTRODUCTION

State of Green, Confederation of Danish Industry, and the Ministry of Foreign Affairs have since COP15 organised joint activities and platforms for Danish private sector participations at the yearly UNFCCC conference (COP)

PURPOSE

The COP is Danish companies' opportunity to influence the global climate agenda and promote the solutions they as companies can contribute with to create a green transition

COP27

At COP26 many initiatives, alliances and commitments were made from both public and private stakeholders. Many stakeholders state, that COP27 will be a platform where these initiatives are taken stock of, as well as a procedure for measuring progress according to Paris goal

Denmark has set ambitious an ambitious climate target, and there will be an opportunity for Denmark's international green leadership as well as the green solutions needed to reach the targets.

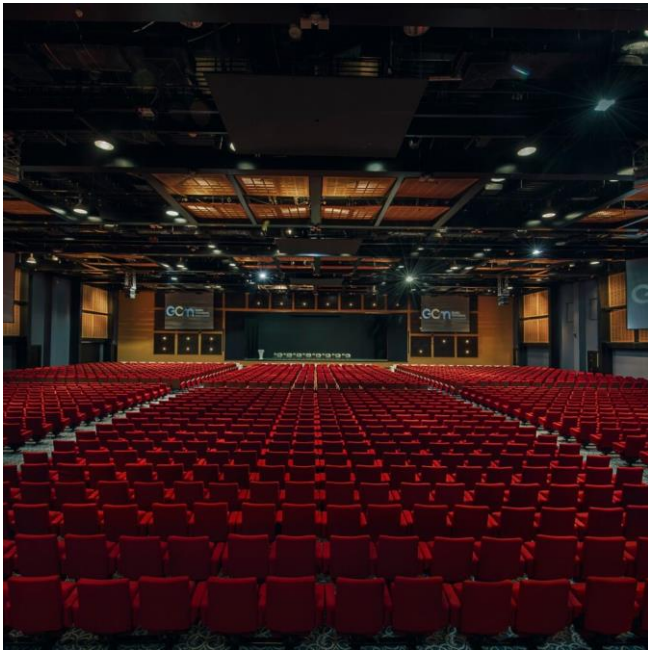

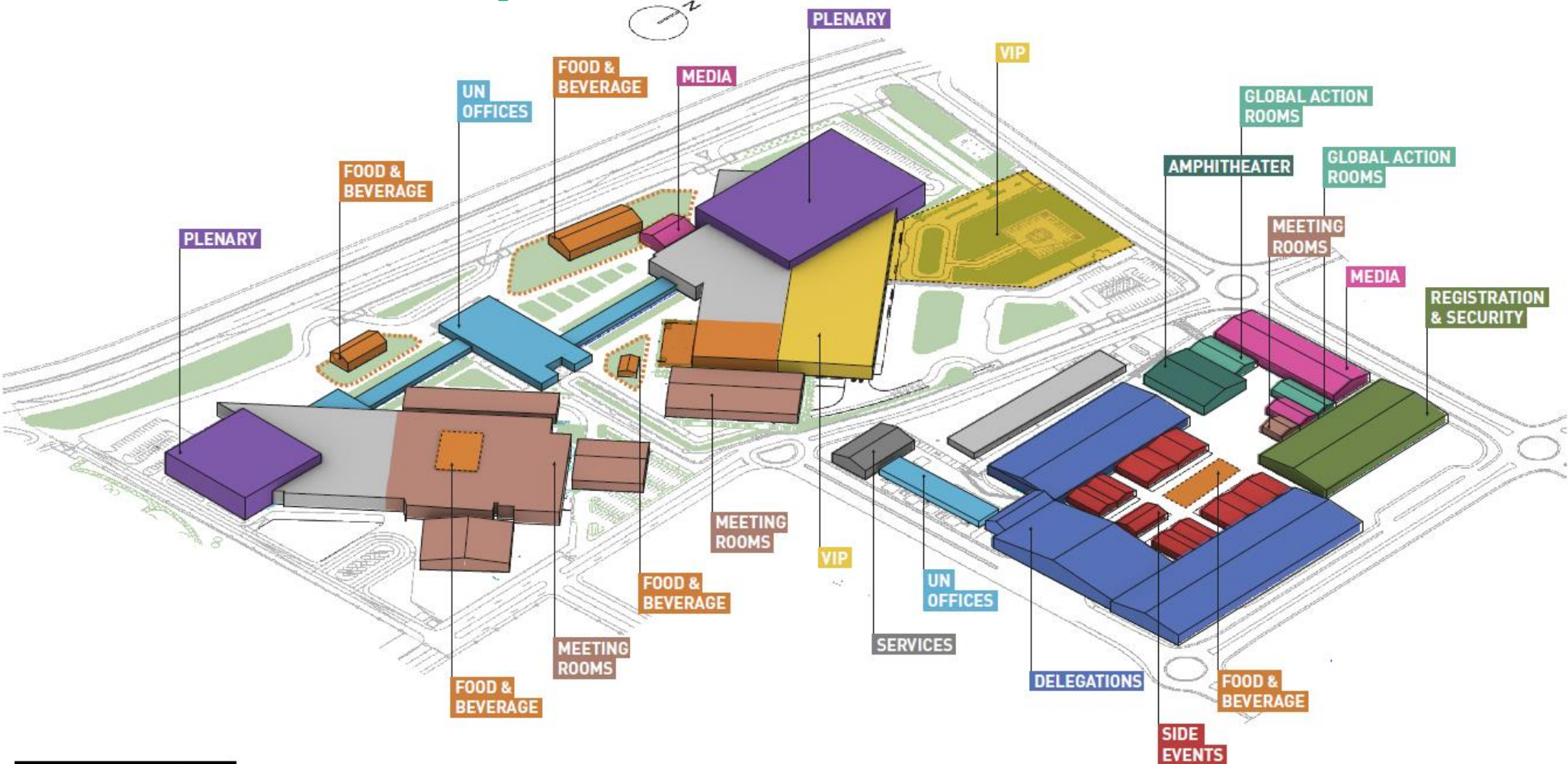

WALKING DISTANCE



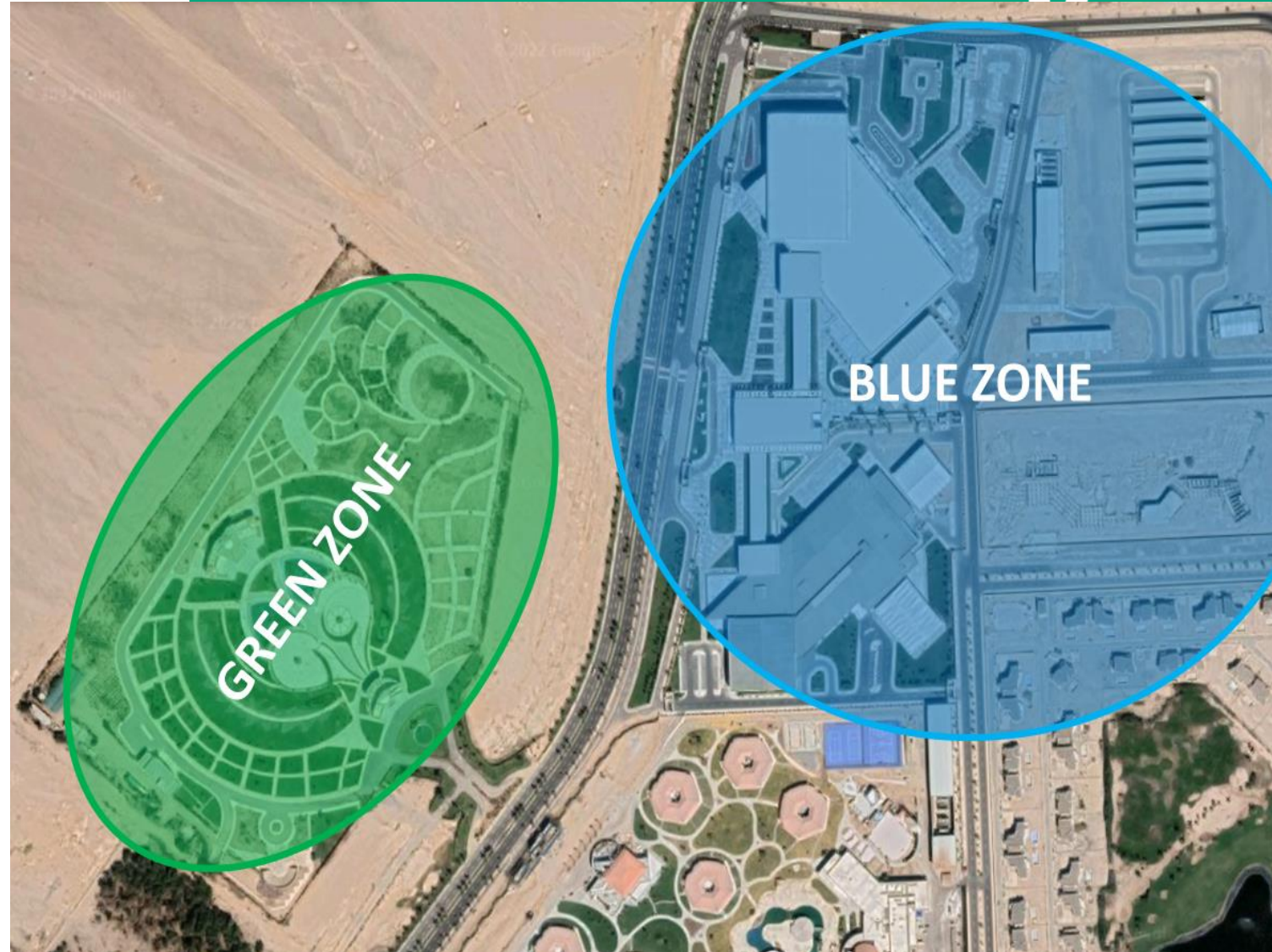

THE BLUE ZONE

UN-managed space which *hosts the negotiations*. The space brings *together delegations from 197 Parties, alongside observer organisations* to share their stories at panel discussions, side events, exhibits, and cultural events. All attendees within the Blue Zone must be accredited by the UNFCCC

THE GREEN ZONE

Managed by the Egypt Government, and is an official *parallel exhibition for Private/Public/NGOs to promote their work and progress* to fight climate change. Registration is handled by Egypt hosts and is usually more open than the Blue Zone

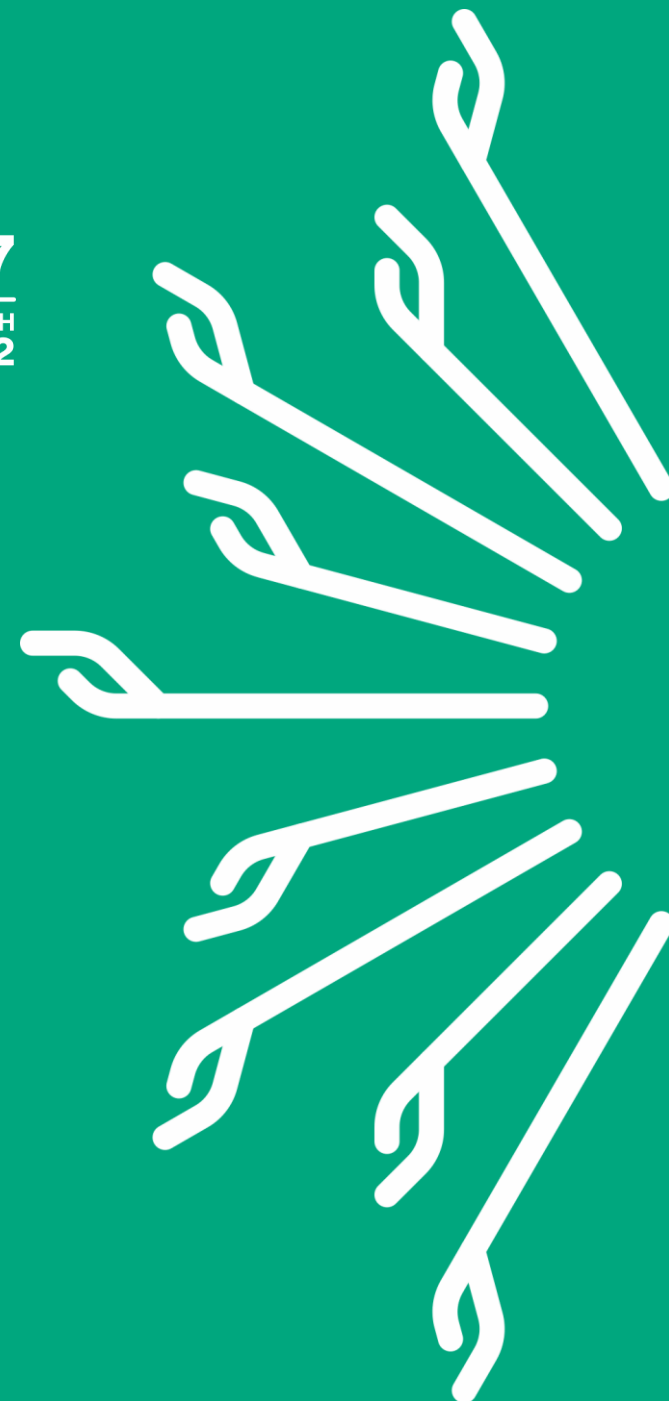

SHARED DANISH PAVILION

- A shared Danish pavilion in the blue zone. Plan to book 100-150 m2 in the period 6-18 November.
- Working title “CLIMATE PARTNERSHIPS TOWARDS 2030” as the joint headline
- The pavilion will serve as a platform for side events, meetings and bilateral dialogues with international decision-makers present at COP27
- Close to the official and high-level stakeholders involved in COP-negotiation
- Strong Danish footprint at the climate negotiation

BLUE ZONE ACCREDITATION

- **AGAIN** this year we have made an agreement to secure Blue Zone accreditation for Danish company representatives participating in a Danish shared pavilion at COP27
- This ensures 1-2 blue zone passes to each company as official partner of the Danish pavilion
- The blue zone accreditation will be issued by the ministry as a part of the official Danish delegation
- NB: All representatives will have to give a electronic sworn declaration confirming you will only reside in the areas relevant to your business at COP27 and that you will not act as a representative of the Danish government
- NB: The passes can not be transferred to other representatives (e.g. customers, other country representatives etc.)
- **You cannot receive extra accreditation. Therefore, aim to utilize whichever other international networks you have to receive further accreditations**

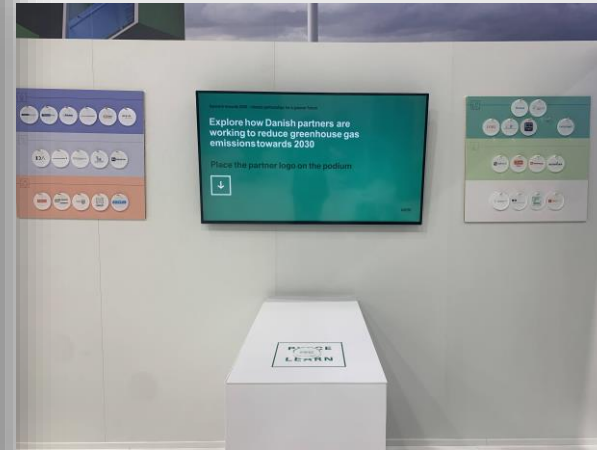
